- Certification at the appropriate levels in Water Treatment, Water Distribution, Wastewater Collection and Wastewater Treatment is required to be obtained in accordance with the Operator Certification Board requirements or existing industry reciprocity agreements.
- Valid Class 5 Driver's License.

In addition to the above qualifications, the job requires 1.5 years of progressively more responsible experience in the following areas:

 Working knowledge of water treatment, water distribution, wastewater collection and wastewater treatment operation, maintenance and troubleshooting processes and procedures.
